Who We Are

This Privacy Notice describes the practices we follow in processing and protecting personal information obtained through our website.

The Information We Collect

How We Use Your Personal Information

Your Rights

If we receive a request from you to exercise any of the above rights, we may ask you to verify your identity before acting on the request. This will ensure that your data is protected and kept secure.

Sharing and Disclosing Your Personal Information

Safeguarding Measures
